We build mentoring relationships, which empower students to navigate high school, succeed in college, and achieve their ambitions. Since 1999, we have matched more than 29,000 across the country students with mentors.

Our whole-school model matches every student in a school with a college-educated mentor, deeply integrated into each school's culture. Mentors commit to working with a single student for a minimum of three years, building their relationships through weekly online communication and monthly in-person meetings.
